Richard Harding made the following motion, "Because of pending personnel changes, I move to cancel Lisa McLachlan's authority to conduct banking transactions on behalf of CCAD and to authorize Kimberly Allen to replace her as banking agent with regard to all CCAD accounts at Legend Bank: CCAD Collection Checking, CCAD Escrow Checking, CCAD Operating Checking, Certificates of Deposit, Online Banking, Debit Card, and any future CCAD bank accounts." Motion was seconded by Bobby Elledge and passed 7-0-0.
- 2024-122 Motion to approve DIR Texas Imagery Service Contract was made by Billy Carlton, seconded by Dee Ann Littlefield, and passed 7-0-0.
