2025-001: A quorum was established (4 of 5 members present).

2025-002: Murray Don Dawson called the meeting to order at 2:00 PM.

2025-003: All present board members submitted Statements of Compliance as required by Tax Code Section 5.041 and the Comptroller.

2025-004: The Oath of Office was administered to Murray Don Dawson, Tony Deweber, Mike Jackson, and Kathleen Middleton.

2025-005: Statements of Officer were submitted by Murray Don Dawson, Tony Deweber, Mike Jackson, and Kathleen Middleton.

2025-006: No members of the general public were present to address the board.
